2022 BCWA Canada Summer Games Selection Criteria:

First place at the 2022 BCWA Canada Games Team Trials will be selected for the 2022 Canada Summer Games Wrestling Team BC. True second will be named as the alternate for the 2022 Canada Summer Games Wrestling Team BC.



Weight Classes:

Females: 38-40 kg, 44 kg, 48 kg, 52 kg, 56 kg, 60 kg, 64 kg, 69 kg, 74 kg, 79 kg, 84 kg Males: 40-44 kg, 48 kg, 52 kg, 56 kg, 60 kg, 65 kg, 70 kg, 76 kg, 85 kg, 98 kg, 98-120 kg

There will be no weight allowance. Athletes will have one hour to make weight at the weigh-ins. There will be no late registration, no day of event adds, no late weigh-ins and a firm start time to ensure a smooth competition for athletes, coaches and spectators.

Canada Games Team Trials

Eligibility Criteria to participate in Team Trials

- 16-19 years old as of December 31, 2022 (Year of birth: 2003-2006)
 - Underage Exemption Applications are available

AND

- Athlete must have placed top 6 at one of the following tournaments in 2019-2022: War on the Floor Elite, Western Canada Age Class, BC championships, Cadet Nationals, Fila Cadet Trials and U17/19 championships
- Athlete is currently wrestling at a college/university program OR
- Athlete has been out of high school for 1 year. Athlete's coach must provide a YTP in order to ensure the safety of the athlete.

Team Trials Seeding Criteria

- Athletes will be seeded based on total points accumulated over the 2021/2022 season at the following tournaments:
 - War on the Floor Elite: 1st: 6 points, 2nd: 4 points, 3rd: 2 points
 - Western Canada Age Class Championships: 1st: 6 points, 2nd: 4 points, 3rd: 2 points
 - BC Provincial Championships: 1st: 12 points, 2nd: 10 points, 3rd: 8 points, 4th: 6 points, 5th: 4 points; 6th: 2 points

Tie Break Criteria

First tie breaker: Head-to-head results between the two athletes at BCWA, BCSS,

and WCL sanctioned competitions during the 2019-2022 season.

Second tie breaker: Highest placing at the 2021 War on the Floor Elite in the targeted

weight class.

Third tie breaker: Highest placing at the 2022 Western Canada Age Class

Championships in the targeted weight class.

Fourth tie breaker: Attendance at BCWA camp for the period 2021-2022.

Fifth tie breaker: Alphabetical order of first name.



Bracketing

- Format to be line bracket double elimination to third place.
- Byes will be placed with seeded wrestlers first, in order of seed. If any byes are remaining they will be placed in the brackets in accordance to the accepted system in use by BC Wrestling.
- Seeds 1 and 2 will be placed on opposite sides of the bracket.
- Finals will be a best-of-three-format.
- True second: if the 2nd and 3rd place finishers from the Team Trials Tournament did NOT meet each other in the challenge tournament, a wrestle-off will occur at the end of the Team Trials Tournament.

Injury Wrestle Offs

No injury wrestle offs will be given to any athletes.

**A wrestler named to the Canada Summer Games Team or alternate may be replaced at any time prior to the Canada Summer Games. This clause may be exercised if in the judgement of appropriate Games Team Coaches (Head Coach and men's or women's as applicable) and BC Wrestling Executive Director by unanimous agreement, the athlete has not met the requirements of the CSG Program, and/or has not displayed a commitment to training outside the required training camps and/or has been disruptive to the team. **

Vaccination:

Canada Games Council is requiring all accredited individuals at the 2022 Games to be fully vaccinated against COVID-19 in order to take part in the Games. BCWA will require proof of vaccination from the top two placers at the 2022 BCWA Canada Summer Games Team Trials to ensure athletes meet eligibility requirements established by the Canada Games Council.

Athletes Excluded:

Excluded from the Canada Games are:

Senior National Team Members

Defined as: Athletes who have held an SR, SR1, SR2 or C1 card at any time; and/or athletes who are part of (on the roster of) a standing Senior National Team (i.e. recognized as Senior National Team member regardless of event participation)

- Athletes who have previously competed at the following events:
- Senior World Championships Olympic Games
- Commonwealth Games
 Pan Am Games
 FISU Games

Underage Exemption Application

If an athlete wishes to request a special dispensation from the minimum age requirement for an athlete, the documents listed in the 2022 Canada Summer Games Technical Package must arrive at the Wrestling Canada Lutte national office no later than June 01, 2022. Please contact BCWA at execdirector@bcwrestling.com to inform us of your intent to submit an underage exemption application before April 20, 2022.
